Southern Oregon Cannabis Company Fights to End Alzheimer's Disease

Local herbal apothecary Breeze Botanicals and Herbal Manufacturer Sun God Medicinals Support the Walk to End Alzheimer's for their Fourth Consecutive Year

CENTRAL POINT, OR - Of the top ten causes of death in the United States, Alzheimer's Disease is the only one that cannot be prevented, cured, delayed, or slowed. There are 16 million Americans working as caregivers for 5 million men and women that suffer from this terrible disease. Every 65 seconds, someone in the US is diagnosed. The Walk to End Alzheimer's, organized every year by the Alzheimer's Association to raise awareness and funds for Alzheimer's support, care, and research, is held in more than 600 communities worldwide. This year, Sun Breeze, Inc. has set a goal of raising at least \$4,500 for the event, significantly increasing donations raised in previous years.

Sun Breeze, Inc. chooses this cause each year due to the potentially powerful connection between the cannabis and hemp products produced and sold by the Sun Breeze family of companies. According to a study published in 2014 in the Journal of Alzheimer's Disease, phytocannabinoids such as delta-9 tetrahydrocannabinol may be powerful neuroprotectants that could be utilized in Alzheimer's treatments. "Many of the customers that we've served at Breeze Botanicals and Sun God Medicinals tell us how their lives have been affected by Alzheimer's, whether they're a patient, caretaker, family member or friend of someone living with the disease," said Brie Malarkey, Founder and CEO of Sun Breeze, Inc.

"Additionally, many of our own staff, family, and friends have been directly impacted by this disease," she continued. "It's important to us that we leverage the success that we've found serving our community to further benefit our species and our planet as a whole" Sun Breeze, Inc. asks that the community join them in raising money and awareness by donating to and joining the Walk to End Alzheimer's.

Sun Breeze, Inc. will be offering free t-shirts to anyone that joins their team, donates a minimum of \$25, and walks with the team during this year's event.
